Dear members of the ELHN Working Group "Free and Unfree Labour,"

At the end of a busy summer term we would like to provide you with some important updates concerning our working group's activities.

COST Action "Worlds of Related Coercions in Work" (WORCK, CA18205)

First and foremost, we are very happy to inform you that our working group has received a four-year funding for a COST Action entitled "Worlds of Related Coercions in WorK" (WORCK). As COST is a funding programme of the EU requiring an equal number of proposers from Eastern and Western Europe and allowing maximum two proposers per country, the development of the proposal was limited to a relatively small group of about 40 people. Now that the proposal is accepted, however, the network can include any researcher, organisation or stakeholder from Europe (and beyond) interested in the COST Action's objectives.

Based on the continuous exchange we have had in our "free and unfree labour" working group over the last six years, the COST Action seeks to reconceptualize the history of work by transgressing the modern-western analytical categories of "productive/unproductive", "free/unfree", "capitalistic/pre-capitalistic" and by investigating dependent labour relations in an epoch- and space-transcending perspective. It brings together hitherto segregated research communities like the study of slavery, serfdom, forced or convict labour and seeks to contribute to current debates on a new social history.

Through regular meetings, a joint digital infrastructure and an over-arching publication strategy the COST Action WORCK is going to discuss bondage and coercion in four closely linked working groups:

Working group 1: "Grammars of Dependency"

Working group 2: "Sites and Fields of Coercion"

Working group 3: "(Im)Mobilisations of the Workforce"

Working group 4: "Intersecting Marginalities"

COST offers new possibilities four our network to deepen existing methodological reflections and broaden our scope by integrating new people, topics and ideas into our discussions. COST will finance working group meetings, workshops, conferences and publications as well as training schools and short-term scientific missions. Also, it fosters the visibility of early career researchers, researchers from Eastern European countries and the Global South as well as the integration of non-academic actors and stakeholders into academic activities.

If you would like to join the COST Action and participate in one or more of the funded activities, you need to get in touch with the national COST coordinator of the country you have scientific affiliation in and ask the coordinator to accept the Memorandum of Understanding (MoU) of our COST Action (CA18205). After that you may choose among three options:

1. Becoming a Management Committee member (only two delegates and two substitutes are allowed per COST country): you can help to coordinate, implement and

manage the COST Action activities and can potentially take up a leadership position within the network.

- 2. Becoming a COST participant: you can join one of the working groups, you can attend workshops and training schools, and you may act as trainer in a training school.
- 3. Becoming a COST grantee: being a COST participant or not, you may spend some time at another research institution of the COST network ("short-term scientific mission"), attend a training school as trainees, or (if you come from an "Inclusiveness Target Country" and are an early career researcher) apply for conference grants.

The 1st Management Committee (MC) meeting will be organised by COST and is going to take place on September 16, 2019, in Brussels. All those you are nominated by their national COST coordinators as MC delegates will receive an official invitation to that meeting within the following weeks. They will then be asked to accept this invitation within 10 days. If you can't attend the meeting, please inform your national COST coordinator, so that your substitute may represent your country at the MC meeting.

The ELHN conference will then be an excellent opportunity for us to meet old and new members of our group and spend three full days of labour history discussion together with a very rich and promising program. Our group will be present in several different sessions.
